  - sore throat, difficulty in swallowing or hoarse voice (more rough or harsh than normal)
  - chills
  - runny, stuffy or congested nose
  - lost sense of taste or smell
  - persistent headache
  - digestive issues (nausea/vomiting, diarrheas, stomach pain)
  - fatigue (lack of energy, extreme tiredness) or falling down more than usual
- 6. If I come in contact with a positive COVID case, or If I suffer from any COVID-19 symptom, I will immediately report to the Hostel and College Authorities.
- 7. <u>I shall not leave the hostel for non-academic reasons</u> and I shall duly enter each entry and

- exit from the hostel in the movement register without fail; and acknowledge that students are not allowed to stay outside the hostel after 7.30pm in consideration of the Pandemic Conditions.
- 8. I hereby state that I will not in any way disturb/tamper/or take the belongings of other students kept in the hostel and in the room allotted to me. I agree to undertake the full responsibility in this matter.
- 9. I shall <u>pay at actual cost any liabilities incurred during my stay</u> due to any damages/ tampering.
