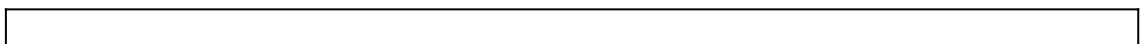

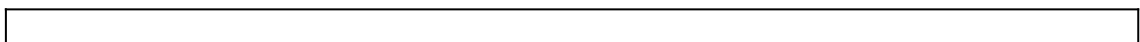
The nominations should be presented to the Returning Officer by the candidate in person along with the proposer and the seconder. All the three persons must bring their College Identity card while filing nominations.
