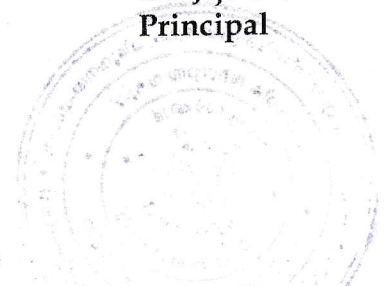

Electoral Roll

The electoral roll shall contain regular, permanent faculty members of departments of Civil Engineering, Mechanical Engineering, Electrical Engineering, Electronics and Communication Engineering, Computer Science and Engineering, Architecture, Computer Applications, Mathematics, Physics, Chemistry, Physical Education and contract faculty members of CET School of Management.


Nominations

1. Members in the Electoral Roll only can contest in the election.
2. Nominated and ex-officio members of the College Council cannot contest in the election.
3. The candidate should have a minimum of 2 years for retiring from service/ minimum 2 years of contract service as on date of notification.
4. Every nomination shall be in the prescribed nomination form (copy available with the Returning Officer and college website) and shall be duly proposed, seconded and consented by only faculty members whose names are in the electoral roll.
5. Name of candidate should be the same as that appearing in the electoral/official college Id card.
6. The nominations should be submitted to the Returning Officer by the candidate in person along with the proposer and the seconder. All the three persons must bring their College Identity card while filing nominations.
