

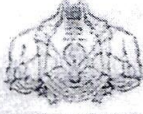

ORDER

As per the Government order read above, guidelines for admission to Student hostels in Government Engineering Colleges in the State were revised. Now, the Director of Technical Education as per the letters read above has reported that representations are received from the student community requesting for a revision in certain guidelines especially the one which regulates the initial selection process.

Government have examined the matter in detail and are pleased to modify the guidelines for admission to Student Hostels of Government Engineering Colleges in the state considering the suggestions from students community as detailed below:

1. All the students belonging to the categories viz. OTHER STATE/ GOVERNMENT OF INDIA NOMINEE should be considered for admission to hostel.
2. Out of the remaining seats, 30% should be earmarked for reservation categories such as SC/ST/PH etc of UG/PG students.
3. From the remaining, 10% should be reserved for PG students.
4. While considering the application from general candidates, Distance and

Annual income (based on the attestation of the concerned authorities) should be considered for allocation of hostel facility.

As the hostel facilities are varied across the Government Engineering Colleges in the State, a uniform order may not benefit the students in all aspects. Hence, in order to allocate the facility of hostel to students from the second year onwards the respective Academic Council will chart out the requirements of the students seeking Hostel facility and will arrange to allocate the facility impartially based on specific criteria.
