RAGGING - PREVENTION

NOTIFICATION ISSUED BY THE PRINCIPAL

Curbing the menace of ragging in Educational Institutions :- Supreme Court guidelines regarding - For information and strict adherence by all concerned (Ref. Verdict writ Petition Civil No. 656 of 1998).

In exercise of the jurisdictions conferred by Article 32 and 142 of the constitution, the Hon'ble Supreme Court of Government of India has issued the following instructions and guidelines.

Ragging is a cognizable and punishable offence. The acts of indiscipline and misbehaviour on the part of the students must be primarily dealt within the institutions. The College authorities / the Principal shall be the disciplinary authority in maintaining high sense of morality and discipline within the campus.

The faith in the teachers for the purpose of maintaining discipline should be restored and the responsibility fixed by emphasizing the same.

Ragging: Ragging is any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or indisciplined activities which causes or is likely to cause annoyance, hardship, a psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such students will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

Strict secrecy will be maintained with respect to such complaints and appropriate action will be taken immediately.

Anyone indulging in ragging is liable to be punished, even be expelled from the Hostel/College as decided by the College Authorities / Principal as the case may be. The power to take disciplinary action will be the sole responsibility / authority of College Authorities / Principal.

If the individuals committing or abetting ragging are not identified, collective punishment could be resorted to, as deterrent punishment.

Course and conduct certificate issued will have a special entry regarding participation / involvement in ragging.

If the institutions fails to curb ragging, Government assistance through AICTE, UGC will be stopped and the University may disaffiliate such institutions.

These guidelines will be enforced strictly in accordance with the prevention of ragging act which is now enforced in the State of Kerala.
