Decisions:

Meeting started at 2.00 pm. IQAC coordinator, Dr. Hari Kumar R welcomed the members and presented the IQAC activities during 2024-25. He also informed that an IQAC committee for the approval of industrial training was formed for scrutinizing the applications for the industrial training by the faculty and also presented following points in the meeting.

- CET is ranked 15th for Architecture in NIRF 2025
- CET is ranked in the band 101-150 in Engineering NIRF 2025
- CET is ranked 1st in NIRF 2024
- 4 MTech accreditation visits were completed
- 2 MTech programs are accredited for 6 years till 2030
- 16 MTech programs are accredited for 3 years till 2027
- Internal audits were conducted twice for all the semesters.
- Preparations about the upcoming UG accreditation visits for the 7 B.Tech. programs.
- 259 internship applications from students were scrutinized and approved by the IQAC subcommittee for internship.
- 78 industrial training applications from faculty were scrutinized and approved by the IQAC committee for the approval of industrial training.
- Details of OBE awareness programs conducted for the students, faculty and staff.

The following discussions were made in the meeting:

- The meeting discussed about the quality enhancement initiatives that needs to be taken for future.
- The Dean of UG studies discussed the matter of reduction in the number of the placements and internships in the college for the students from the previous academic year.
- Mr. Sreeji KG suggested that he will make arrangements with some eminent alumni to conduct certain interactive session to the students to motivate them. He also suggested that steps may be taken to arrange the industrial interactive sessions in the orientation program for the first-year students.
- Ms. Manju Nair commented that the measures need to be taken to improve the attitude of the students in interviews conducted as part of campus placements.
- Dr. Suresh K suggested to conduct hackathons and hands-on interactive programs with industrial experts which will be effective to motivate the students to go for internships in various industries.

18 members were present in the meeting. The meeting was concluded at 3:30 pm with the vote of thanks of Dr. Reshmi S Bhooshan, Co-coordinator, IQAC.
